Based on the attached REC receipts, in 2016, the County purchased 713,000 kWh in RECs from Gravity Renewables, 1,825,000 kWh in RECs from Constellation Energy, and 4,000,000 kWh in RECs from Integrys Energy Services of New York, Inc. in 2016, amounting to 6,538,000 kWh worth of RECs for 2016, which exceeds the County's total energy usage in 2014 (which likely remained about the same in 2016).

TCRMM funds Finger Lakes ReUse, which offers a deconstruction program that features building disassembly for reuse, thus reducing the generation of C&D materials. This facility accepts and diverts curbside and drop off residential single stream, commercial recycling, source separated organics, electronic waste, household hazardous waste, scrap metal, yard waste, propane tanks, fire extinguishers, and other materials from the landfill. **Program Summary:** Residents of Tompkins County have access to 14 food scraps recycling drop spots throughout Tompkins County. Tompkins County Department of Recycling and Materials Management (TCRMM) outline plans to expand this to 20 drop spots by 2020. At these drop spots, residents may sign out a food scraps recycling toolkit free of charge, obtain replacement compostable bins liners, and drop off their food scraps, free of charge. In 2017, these drop spots diverted 323 tons of food scraps & paper towels. Residents of Tompkins County may drop off yard waste at no charge at the Recycling and Solid Waste Center (RSWC). Select municipalities offer yard waste hauling via a bag & tag system. Food scraps and yard waste collected through these programs are sent to Cayuga Compost in Tompkins County for processing. TCRMM pays for the processing of this material via contract, subsidizing organics waste diversion in the county.
